1. Setup from 7:30 am; must be completed by 9:30 am. Opening Circle is at 9:45. Public hours are 10 am - 5 pm.
2. Products and services: Healing Arts Festival may determine the eligibility of all products & services. Producer reserves the right to deny sale of items that have not been listed on the application. Producer's judgment shall be final and binding. No music without headphones.
3. Professionalism: Exhibitor agrees to maintain dignity and integrity of the Festival and will not perform any acts of a harmful nature. The Festival reserves the sole right to ask any Exhibitor or its employees to leave the Festival whom they feel are not acting in the best interest of the Festival. Exhibitors should refrain from using cell phones or eating in the exhibit area.
4. Booth: No booth may have more than one reader without explicit prior approval. Exhibits must be open and staffed during all Festival hours (monitors will be available for short breaks). No interior signs higher than 4.5 feet.
5. Laws, etc. Exhibitor agrees to abide by all applicable laws, ordinances and regulations pertaining to health, fire prevention, public safety, business licenses, sales tax permits and applicable liability insurance. If you provide goods for sale, you must have a sellers permit on file with the HAF Festival office and available at your booth. For more information, visit the Board of Equalization at www.boe.ca.gov or call **1-800-400-7115**. Open flames are not permitted.
6. Liability: Healing Arts Festival is not liable for personal injury, or for lost or stolen goods. Insurance is exhibitor's responsibility, and is recommended. Exhibitor is liable for any damage they cause to booths, decorations, or property. Exhibitor agrees to indemnify & save harmless the sponsor and its agents from any claims, causes of action, and suits resulting from any damage, injury, or loss to any persons connected to the exercise of Exhibitor privileges granted herein.
7. Cancellations: In the event that any outside force (including disruption to hotel space) prevents the fair from taking place, Healing Arts Festival reserves the right to retain Exhibitor payments to cover expenses. Sponsor has the option to cancel the Festival by 30 days prior to event and will return booth fees to the exhibitors.
8. Booth sales are final. Rentor may not sub-let or resell booth space. Producer reserves the right to alter the booth layout plan. Requests for specific booths will be taken into consideration, however, Producer has sole discretion to assign booths as Producer deems appropriate.
9. Photographs: Exhibitors agree to permit photographs of their booths and their work at the Healing Arts Festival to be taken by Producer to be used for the purposes of promoting and advertising the event. All photographs remain the property of Healing Arts Festival.
10. This agreement constitutes the entire contract between the Healing Arts Festival and the Exhibitor. Any questions or issues not covered in this contract shall be subject solely to the decision of the Producer.
